I would like to recall the discussions had with the Hon'ble Minister with regard to sanction of new projects for small & medium towns under NUDM and submit the following few lines for consideration.

Govt of Andhra Pradesh have furnished Detailed Project Reports (DPRs) costing Rs.898.64 Cr. in respect of 11 water supply projects during the Transitional Phase of JnNURM. But, the Ministry has not considered the sanction of the projects due to non-conduct of elections to local bodies before 31<sup>st</sup> March, 2014. Hence, the State has forgone the central allocation of funds to the projects under Transitional Phase.

Further, I wish to reiterate that due to bifurcation of the state, there is severe constraint on finances for residual Andhra Pradesh. As such, the State is not in a position to take up the projects with own resources due to paucity of funds.

The Urban Local Bodies (ULBs) furnished the proposals to the Government in respect of projects relating to basic service sectors like water supply and sewerage. The list of the proposals (18 Nos) costing Rs.1836.48 Cr. along with DPRs is enclosed.

In view of the above, I request the Hon'ble Minister to kindly consider the sanction of projects under National Urban Development Mission (NUDM) at an early date.

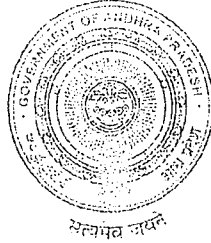
