2) Letter No.127/PH/EC1/2015,Dt.05-05-2015 of SE(PH), Rajahmundry,
submitting the recommended list of eligible candidates for appointment as
GEA.

In pursuance of the orders contained in the reference 1st cited and with reference
to the letter under reference 2nd cited, the following candidates in Zone-II who have
been recommended by the Superintending Engineer (PH), Rajahmundry for
appointment as Graduate Engineer Apprentice (G.E.A) under Apprentice Act 1961, are
hereby appointed as Graduate Engineer Apprentice under Apprentice Act 1961 with a
stipend of Rs.15,280 /- (Rupees Fifteen thousand and two hundred eighty only) Per
month and posted as GEA as indicated in annexure appended to this order. The above
appointment shall be subject to the following conditions.

- 1) The candidate shall execute an indemnity bond in the prescribed proforma as
required under Apprenticeship Act 1961.
- 2) The candidates shall report within 15 days from date of receipt of this orders
failing which, his / her candidature is liable for deletion from the appointment list
without any intimation and or further correspondence.
- 3) The candidate should submit all original certificates like education qualifications,
local status, caste and community etc., for verification along with two sets of
attested Xerox copies of the above certificates at the time of reporting .
- 4) He / she shall undergo Apprenticeship for a period of two (2) years from the date
of joining or till new candidates are appointed by APPSC or till termination of
his/her apprenticeship whichever is earlier. Soon after completion of his/her
apprenticeship, the apprenticeship is deemed to have been terminated.
- 5) He/she shall be entitled for grant of casual leave not exceeding 12 days in a
calendar year besides medical leave for 15 days and E.O.L for a period not
exceeding 10 days.
- 6) He / she shall work in (PH) Division / ULB independently or under the supervision
of the Dy. Executive Engineer / Municipal Engineer Grade-II and discharge all the

duties as section officer and as per directions of immediate controlling authority of the concerned ULB / PH Division.

- 7) He/she is informed that, for slackness in maintaining records / registers in discharging duties, if any, are noticed he / she shall be liable for termination without assigning any reasons there for or notice, besides criminal action in case of financial embezzlement.
- 8) He / she is liable for transfer from one ULB to another ULB or (PH) Division vice-versa within zone.
- 9) He/she is informed that the Engineer-in-Chief (PH), A.P is the appropriate authority in all the matters relating to the Apprenticeship
- 10) He/she should abide by the instructions issued from time to time issued by Engineer-in-Chief (PH), A.P /or his nominee/ULB/PH Division authorities/Superintending Engineer (PH).
- 11) The G.E.A is informed that mere appointment as Apprentice does not confer any right to claim by the individual for probation declaration, regularization/absorption of services into PH & ME Department.
- 12) He/she is also informed that, the Engineer-in-Chief (PH) is empowered to terminate any Apprentice or all Apprentices at any time without assigning any reason(s)/notice therefor before expiry of the Apprenticeship period.

The candidates, who are appointed as Graduate Engineer Apprentice and posted as per the annexure appended to this order shall report before the Superintending Engineer (PH) concerned within 15 days from the date of receipt of this order along with indemnity bond and all relevant certificates in original for verification. The Superintending Engineer (PH) concerned shall issue reposting orders after his/her reporting to him and after receipt of indemnity bond properly executed and upon satisfying himself with all the credentials/original certificates of the candidate.


