In the reference cited, Government have informed that, they have decided to implement the Judgement date 03.11.2017 in Civil Appeal Nos. 17869-17870/2017 of Hon'ble Supreme Court and directed all the Departments as follows (Para-2 of the G.O) in connection with the above subject:-

- a) To revert the employees who promoted based on the Engineering Degrees of the said Deemed Universities with the direction to attend and qualify in the Test conduct by the All India Council of Technical Education to get their benefit or promotion or other financial benefits thereon.
- b) To suspend/recall/cancel the Degrees issued by the Universities of A.P to those students studied based on the Engineering Degrees of said Deemed Universities and issue notices to such students with a direction to attend and qualify in the test conduct by All India Council of Technical Education to restore their Degrees issued by the University.

Further, the Government have requested to implement the Judgement pronounced by the Hon'ble Supreme Court of India Dated 03.11.2017 in Civil Appeal Nos.17869-17870/2017 and further directed to follow the contents mentioned in the Para-1 of the G.O. Cited.
